

Framework for Continuous Improvement

- Industry, Regulators, Advocates, and Public Alike Agree
 - Zero Accident is Our Indisputable Goal
 - Work to Do
- SMS is a Widely Accepted Framework for Continuous Improvement and Learning – More from Chris Hart
- Development of API's RP 1173 began in December 2012
 - Monthly meetings, with plenty of team meetings on side
 - A consensus has finally emerged that's what you'll hear today
 - Broad alignment on the added safety value, but also on the need for flexibility
