






API RP 1173 Path Forward

Under API / ANSI requirements, API RP 1173 is due for a "standards action" by 2022











All standards must be extended, revised, reaffirmed within 5-years of last action (RP 1173 published in July 2015)

API PSMS Assessment Program

Assessments Completed to Date

- **2020 2 Large Gas Operators**
- 2021 2 Large Liquids Operators; 1 Large Gas Operators; 1 Small Steam Utility
- 2022 2 Large + 2 Small Liquids Operators; 2 Large Gas Operators
- **2023 6 Operators in various stages of planning**

Benchmarking distributed to participants in July and ongoing as operators participate

Themes and Learnings:

- Safety Culture and Leadership is one of the highest scoring areas with improvements to safety communications and reporting being seen across operators.
- **Stakeholder Engagement can be improved RP 1185 publication in 2023**
- **External Learnings incorporation can be improved**

The Mission

A 2022 industry group goal is to increase Pipeline SMS support of contractors. To develop a industry led contractor framework and assessment tool that guides contractors in their Pipeline SMS adoption, while providing flexibility and scale for the diversity of work contractors perform. This may serve as a base template for small operators.

Accounts for the diverse spectrum of contractors, subsets applicable RP statements, and leads through examples.




Third Party Assessment for contractors
