Technical Hazardous Liquid Pipeline Standards Advisory Committee Meeting Minutes

August 17, 2022

Mr. Alan Mayberry, Associate Administrator for the Office of Pipeline Safety, Pipeline and Hazardous Materials Safety Administration (PHMSA), U.S. Department of Transportation (DOT), serves as the Designated Federal Officer (DFO) of the Technical Hazardous Liquid Pipeline Safety Standards Committee also known as the Liquid Pipeline Advisory Committee (LPAC).

Mr. Mayberry started the LPAC meeting on August 17, 2022, at 10:35 am ET by introducing the Chairperson, Ms. Diane Burman, Commissioner for the New York State Public Service Commission.

The meeting was held virtually and was open to the public.

I. DFO Opening Remarks

IV. Opening Remarks

The DFO stated that PHMSA's Deputy Administrator, Tristan Brown, could not attend the meeting but sent his regards and was very interested in the outcome of the meeting. In addition, the DFO recognized the PHMSA staff and the LPAC members for their hard work, addressed the diverse backgrounds of the committee membership, and highlighted the important work expected to be carried out at the meeting.

V. Agenda Adoption

Chairperson Burman and the DFO reviewed the agenda for the meeting. The LPAC agenda for the day was to discuss the Coastal Ecological Unusually Sensitive Areas Interim Final Rule (IFR). Chairperson Burman asked if there were any questions from PHMSA staff or the committee on the agenda. There were no questions on the agenda.

VI. Committee Discussion and Voting

Mr. Sayler Palabrica, PHMSA, provided a presentation on the following topics: background information relevant to the IFR, the IFR's requirements and implementation, impacted mileage, regulatory impact analysis, rulemaking procedures, summary of public comments received on these topics, and PHMSA's responses to those comments.

Liquid Pipeline Advisory Committee August 17, 2022 Page 3 of 5 After Mr. Palabrica presented the above-listed items, Chairperson Burman opened the meeting for public comment, followed by committee and PHMSA staff discussion.

Thereafter, Mr. Palabrica resumed his presentation with a discussion of the applicability, definitions, data sources in the IFR, a summary of public comments received on these topics, and PHMSA's responses to those comments. After Mr. Palabrica concluded his presentation, Member Todd Denton requested a short break for industry members to have a discussion before a vote on the IFR. The DFO and committee chair granted this request, and the committee took a break between 12:43 - 1:21 pm ET.

After returning from the break, Member David Barnett made a motion to vote on one item – the applicability, definitions, and data sources in the IFR – and Member Shawn Lyon seconded that motion. The committee unanimously voted to approve the below motion:

The interim final rule as published in the Federal Register, with regards to the applicability, definitions, and data sources are technically feasible, reasonable, cost-effective, and practicable if PHMSA consider the following:

With respect to regulated rural gathering lines, rural low-stress pipelines, and certain coastal waters between the 3 nautical mile line and the 12 nautical mile line, PHMSA exercise enforcement discretion for the requirements in the IFR through the date of publication of the final rule or 08/17/2023, whichever is earlier.

After voting on the IFR was complete, Member Graham Bacon made a motion, seconded by Member David Barnett, to approve the below motion:
